ADVANTAGES AND OBLIGATIONS



EU CITIZENSHIP

EU member states: Austria, Belgium, Bulgaria, Croatia, Republic of Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia, Spain and Sweden.

Freedom of movement:

- Travel: up to three months without formalities
- Live: sufficient financial means (work, study, retire, look for a job, ...)
- Social rights: similar to nationals
- **Red flag:** financial aid in another EU member state



OBLIGATIONS

- Voting: obligated for local (except Flanders), regional, federal and European elections from the age of 18
- Polling station attendant: list drafted based on profession and residence address
- **Jury duty:** between age of 28 and 65



SCENARIOS

- General rule: based on years of continuous legal stay
- More flexible conditions in specific circumstances

LEGAL STAY AND PRIMARY RESIDENCE

Legal stay

- Uninterrupted legal stay prior to the application
- Accepted documents:
 - Electronic residence cards type A, B, C, D, E, E+, F, F+, H, M and M with permanent residence rights
 - Annex 15
 - Beneficiaries of the withdrawal agreement: also annex 56 prior to M-card
 - EU citizens: also annex 19 prior to E-card
 - Family members of EU citizens: also annex 19ter and orange card (attestation of immatriculation) prior to Fcard

Primary residence

Officially registered in the civil registers (town hall)

Continuous legal stay and primary residence

- No interruptions in residence rights AND official address registration in Belgian town hall
- Temporary absence of maximum six months is allowed (combined reported absences may not exceed 1/5th of total required duration)

BELGIAN NATIONALITY FOR ADULTS RESIDENCE PERMIT OF UNLIMITED DURATION

Residence permit of unlimited duration

- Being authorized to reside on the Belgian territory for an unlimited time (unconditional residence rights)
- Evaluated at the time of the application for Belgian nationality
- Accepted documents:
 - Electronic residence card type B
 - Electronic residence card type K (previously C)
 - Electronic residence card type L (previously D)
 - Electronic residence card type E / E+
 - Electronic residence card type F / F+
 - Electronic residence card type M
 - Electronic residence card type M with permanent right of residence

INTEGRATION

Integration in Belgian society: accepted documents

- Nationality application based on 5 year legal stay
 - Diploma of an official education institute in Belgium (minimum higher secondary education), obtained in an official Belgian language
 - Completed a recognised vocational training of minimum 400 hours
 - Successfully followed an integration course, organized by the Communities
 - Continuous employment or self-employment in the 5 years prior to the application
- Nationality application based on marriage to a Belgian citizen or parent of a minor Belgian child
 - Diploma of an official education institute in Belgian (minimum higher secondary education), obtained in an official Belgian language
 - Successfully followed an integration course, organized by the Communities
 - Completed a recognized vocational training of minimum 400 hours AND having worked for at least 234 days as an employer or 3 full quarters as a self-employed person in the 5 years prior to the application

≠ community participation (10 year legal stay)

- All documents regarding integration in Belgian society should be provided, accompanied by a letter explaining what you have been doing for the past 10 years.
- Examples: diploma, going to school, following an integration course, working, hobby's, volunteer work, membership of social groups, ...

BELGIAN NATIONALITY FOR ADULTS LANGUAGE

- Knowledge of one of the Belgian official languages: Dutch, French or German (regardless of where you live)
- Minimum level A2 (Common European Reference Frame), or level 1.2 used in Belgian centres for adult learning
- Accepted documents:
 - Diploma of an education institute in Belgium (minimum higher secondary education)
 - Diploma of an education institute in EU (in or concerning an official Belgian language, diploma needs to be recognized by the Communities, minimum higher secondary education)
 - Completed a vocational training of minimum 400 hours
 - Successfully completed an integration course (**Red flag**: make sure language is mentioned on the document)
 - Continuous work in the 5 years prior to the application
 - Certificate for passing a language test
 - Government language attestation (SELOR, VDAB, Actiris, FOREM, Arbeitsamt, Bruxelles Formation)
- Usually proven together with integration condition

BELGIAN NATIONALITY FOR ADULTS ECONOMIC PARTICIPATION

- Requirement of having worked for a minimum number of days prior to the application
- Categories:
 - Employee: having worked in Belgium for at least 468 days in the 5 years prior to the application
 - Self-employed: having paid the social security contributions in Belgium for at least 6 quarters
- Accepted documents:
 - Individual accounts
 - Attestation of government agencies
 - Proof of payment of social security contributions (e.g. Social Secretariat)
- Calculation of working days:
 - Working days and equivalent (maternity leave, paid holidays, etc.)
 - Parttime labour (calculation based on fulltime equivalent)
 - Education (secondary education, higher education, vocational training of at least 400 hours): only when education is completed. Equivalent working days depend on type of education.

BELGIAN NATIONALITY FOR ADULTS **DOCUMENTS AND APPLICATION PROCESS**

Documents:

- In all categories: recent birth certificate (translated and legalised) + proof of payment registration rights (currently 150 EUR)
- **Red flag:** your name must appear the same on all official documents
- Depending on the situation: integration, knowledge official language, economic participation, marriage certificate, birth certificate child, address history, proof of disability, ...
- Town hall usually provides proof of legal stay, primary residence and residence rights of unlimited duration

Application process:

- Application is started at town hall of residence
- Civil servant will check if the file is complete and deliver a receipt
- File is transferred to the Public Prosecutor's Office, the Immigration Office and the National Security Office
- > Public Prosecutor's Office will deliver a binding opinion within four months
- ▶ If positive: civil servant will register your nationality declaration and you are now a Belgian citizen
- If negative: appeal possible at First Instance Court within 15 days
- Refusal if conditions are not met or in case of 'important facts specific to the individual': e.g. criminal conviction or investigation (also: traffic violations!), danger for national security, impossible to verify your identity, social or fiscal fraud, etc.

BELGIAN NATIONALITY FOR MINOR CHILDREN



BELGIAN NATIONALITY FOR CHILDREN SCENARIOS

- Automatically or following a declaration by one of the parents
- General rule: children living in Belgium when parent acquires Belgian nationality will automatically get Belgian nationality as well if
 - They are living in Belgium with their parent at the time they acquire nationality
 - The parent has parental authority

Red flag: children who are living abroad will not acquire Belgian nationality

> Other categories depend on place of birth of parent and child, and timing of Belgian nationality parent

BELGIAN NATIONALITY FOR CHILDREN CHILDREN BORN IN BELGIUM

- Children who are born in Belgium after parent acquired Belgian nationality
 - Automatic nationality if parent has registered the birth
- Children who are born in Belgium without any of the parents having Belgian nationality
 - If the parent was born in Belgium, the child would automatically become Belgian if this parent had their primary residence in Belgium for 5 years in the 10 years prior to the application
 - If the parent was not born in Belgium a nationality declaration needs to be submitted by both parents before the age of 12
 - Both parents need to have legal stay and primary residence for 10 years prior to the declaration
 - At least one of the parents has an unlimited right of residence in Belgium
 - The child has had their main residence in Belgium continuously since birth
 - The Public Prosecutor's Office will give a binding advice within 4 months

BELGIAN NATIONALITY FOR CHILDREN CHILDREN BORN OUTSIDE OF BELGIUM

- Children who are *not* born in Belgium after parent acquired Belgian nationality
 - If parent was also born outside of Belgium, a nationality declaration needs to be done before the age of 5
 - Parent does the declaration at the town hall of his residence or the local Belgian embassy
 - Extension of 5 year time limit can be asked at the First Instance Court
 - If parent was born in Belgium, the child would automatically receive the Belgian nationality when the birth is registered
 - Registration in Belgium at town hall and registration at local Belgian embassy

 Multiple nationality allowed under both Belgian nationality code and British Nationality Act 1981

FRAGOMEN



5 YEARS

- economic integration
 - employees : 468 days of employment over the past 5 years
 - self-employed : proof of payment of social security contributions for the past 6 quarters
 - continuous employment : gaps
 - employment with EU or international organisations
 - posted work does it count?
 - studying in Belgium



5 YEARS

- social integration
 - 5 years of continuous employment/self-employment
 - integration course
 - proof of having followed vocational training min. 400 hours
 - degree or certificate from a Belgian educational institution obtained in French/Dutch/German (minimum level: secondary education)

FRAGOMEN



5 YEARS

- Language aptitude
 - 5 years of continuous employment/self-employment
 - A2 level in French, Dutch or German
 - recognised provider



5 YEARS

- 5 years of continuous and legal residency (alternative basis)
 - having reach retirement age; or
 - being unable to work due to disability or incapacity

FRAGOMEN



10 YEARS

- Proof of social and/or economic participation
 - open-ended means of proof
- Letter of motivation
