BUSINESS TRAVEL FROM THE UK TO BELGIUM



BUSINESS TRAVEL TO BELGIUM AS OF JANUARY 2021

- EU and UK agreed on visa waiver program for entry and stay up to 90 days in any 180 days in Schengen (including Belgium)
- EU and UK agreed on Trade and Cooperation Agreement (TCA):
 - Entry of business visitors without the requirement of a work permit, or economic needs test
 - Specific set of activities (no reservations by Belgium)
 - For a period up to 90 days in any 6-month period
 - Directly applicable
 - Co-exist with the exemptions foreseen in Regional policies, whatever is most favorable (artists, journalists, ..)



BUSINESS TRAVEL TO BELGIUM AS OF JANUARY 2021

- Set of activities exempt from work permit based upon TCA:
 - Meetings and consultations
 - Research and design
 - Marketing research
 - Training seminars
 - Trade fairs and exhibitions
 - Sales
 - Purchasing
 - After-sales or after-lease services
 - Commercial transactions
 - Tourism personnel
 - Translation and interpretation
 - Setting up an enterprise

BUSINESS TRAVEL TO BELGIUM

IMPORTANT GUIDELINES



Time Limits

- Consider all days spent in the Schengen Area (including personal travel)
- Smart Borders in 2023?



Frequency of the trips

Consider the frequency of the business trips as this can be a red flag for national authorities



Documentation and formalities

Check passport validity (min. 6 months required)

Allowed activities and possibility to travel?

Consider whether activities are allowed under the business visitor status in a destination country

- Posted Worker notification, Social Security Certificates of Coverage?
- ETIAS pre-travel authorisation in 2023 ?



MOVING TO BELGIUM

EMPLOYEES

SINGLE PERMIT

- Single permit = a combined work and residence authorization for foreign workers for more than 90 days
- Validity: up to 3 years
- For work with one specific employer in Belgium
- Several categories, with different eligibility requirements:
 - Highly-Skilled and Managerial
 - ✓ EU Blue Card
 - Intra-Corporate Transferees (ICT)
 - ✓ (Shortage occupation) and Labour Market Test (LMT)
- > Possible for assignment (posted worker) and local hire, if assignment:
 - posted worker (Limosa) notification
 - certificate of coverage for social security or Belgian social security exemption
- Direct family members (spouse/partner, children below 18) can relocate to Belgium and have free access to labour market as employee



SELF-EMPLOYED

PROFESSIONAL CARD

- Professional card authorizes the entrepreneur (self-employed as natural person or through company) to engage in economic activities in Belgium.
- > Once obtained, the applicant automatically qualifies for a long stay visa and residence permit.
- ► Validity: 2-5 years (validity of visa and residence permit aligned)
- **Eligibility:** "economic added value". In our experience, authorities consider:
 - evidence of (successful) previous professional experience, and
 - viable business plan and financial plan or service agreement
- Direct family members (spouse/partner, children below 18) can relocate to Belgium and have free access to labour market as employee (not self-employed)

STUDENTS

STUDENT PERMIT + SEARCH YEAR PERMIT

- **Student permit** allows third country national to reside in Belgium to study at a higher education institution
- ► Validity: length of the studies + sufficient progress
- **Eligibility:**
 - Higher education program (or preparatory language course)
 - Full time studies (54 ECTS)
 - Recognized higher education institution (for private institutions different immigration process)
 - Proof of sufficient resources
- **Work:** maximum 20 hours/week during school year, unlimited during official holidays
- Direct family members (spouse/partner, children below 18) can relocate to Belgium but don't have free access to labour market
- Intra-EU mobility option
- > After graduating: search year permit, 12 months to look for a job or set up a business

SPECIAL IDENTITY CARD (SIC)

M-CARD APPLICATION AFTER 31 DECEMBER 2021

- Special Identity Card (SIC) for employees of international organizations
- Limited to the duration of the function with the international organization
- UK nationals and their family members can apply for status as beneficiaries of the Withdrawal Agreement (M-card)
- If end of function as an employee of an international organization is after the end of the M-card application period (31 December 2021) you can still apply
- M-card application within three months after the end of role as an employee of international organization

RETIREMENT

DISCRETIONARY APPLICATION

- Not foreseen in legislation general **discretionary** competence of the State Secretary for asylum and migration
- **Eligibility**: in our experience, authorities consider:
 - Pre-existing link with Belgium (e.g., through earlier long-term residence, family ties, strong professional ties)
 - Sufficient regular income other than from employment
- Lengthy and uncertain process
- **Validity:** 1 year, renewable

LONG TERM RESIDENCE



EU LONG TERM RESIDENCE L-CARD

Eligibility

- Legal and continuous residence of five years
 - Periods of stay as a student are only counted half
 - Periods of stay considered as temporary in nature, such as stay a as a seconded employee or a seasonal worker, are not taken into account
- Sufficient income
- Health insurance

Benefits

- Unconditional undertake any professional activity you wish
- Can only be rescinded in exceptional circumstances and in case of absence from the EU for more than twelve consecutive months or from Belgium for more than six years.
